

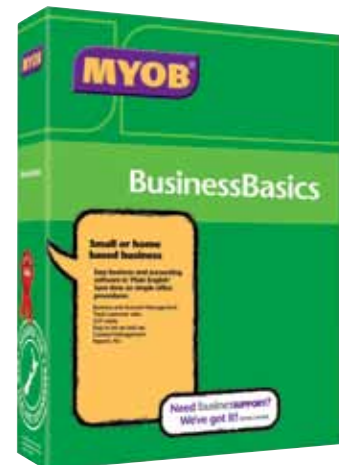

Create quotes that convert to invoices
